SWEEPSTAKES DESCRIPTION:

HOW TO ENTER:

Registered Twitter users who are legal residents of the 48 contiguous United States and are 18 years of age and older will be able to take part in this Sweepstakes. To participate in the Sweepstakes, listeners and users must do the following:

- 1. Participants must go to www.vzw.com/blackmusicmonth and follow the on-screen instructions to "Tweet To Enter!"

ELIGIBILITY RESTRICTIONS:
